#### **TERMS AND CONDITIONS**

- 1. The name of the project shall be DHA Bahawalpur (Orchard Enclave).
- 2. The Plots offered to the buyers in the project shall be on ownership basis & allotment subject to balloting and allotment policy.
- 3. If purchased on installments, quarterly installments shall be payable by the 5<sup>th</sup> of each month through demand draft / pay order.
- 4. The applicant shall make the payment of installments within the period specified. If the applicant fails to pay the payment / dues within the period as mentioned in the final notice, the application will be liable to cancellation as per term (5) of this form.
- 5. In case of failure on the part of the applicant to make payments within the prescribed period as per schedule or after being served the FINAL NOTICE, the application / allotment will stand cancelled. The amount deposited by the applicant shall be refunded after deduction of 20% of total deposited amount and membership fee.
- 6. The applicant will pay transfer expenses, documentation charges and all other ancillary and miscellaneous expenses to the DHA Bahawalpur as determined for fulfillment of formalities of various departments / agencies as and when asked by the DHA Bahawalpur within the prescribed period (<u>legal time</u>), the cost of the unit does not include land / ground rent, lease execution registration and expenses like; electric, sui-gas, water and meter charges.
