- 4. Forwarding letter giving details of the sale / transfer documents.
- 5. Undertaking by the Donee regarding variation fee.
- 6. Photocopies of the Computerized National Identity Card CNIC of both Donor and Donee duly attested by the Oath Commissioner / Class one officer / regular member.
- 7. 2x passport size photographs of the Donee duly attested.
- 8. **Associate** Membership (AM Fee Rs. 40,000/-) form of purchaser.
- 9. Cost of AM Form Rs. 350/-
- 10. Original Transfer / Sale deed along with affidavits of seller & purchaser regarding surrender of the deed (In case of registered plot).
- 11. Transfer Fee according to the size of the plot.
- 12. Copy of FRC (Family Registration Certificate) dully attested by NADRA.
